RTI POLICY, HATICHONG COLLEGE:

The Right to Information Act, 2005 empowers the citizens of our country to question the government. The act promotes transparency and accountability in the working of the government of our country. The act also helps in minimizing corruption in the government sector and work for the people in a better way.

Hatichong College, Nagaon, Assam formed a RTI Cell by General Meeting (Teacher`s Unit) held on 20/01/2017 vide resolution No. 01 to promote transparency and accountability in the working of the public authorities and to make the institution responsible for the society in true sense of the term.

PROCEDURE OF APPLICATION:

- a. The applicant must be an Indian citizen.
- b. The RTI fees should be paid in the form PO/DD/MO or by Cash to the appropriate authority (Principal of the college) which is specified in the RTI Act.
- c. The applicant should furnish full name and address, contact details, email address. The required information should be clearly visible in the application.
- d. The law instructs that the information should be provided to the seekers within 30 days.
- e. Application can be handwritten or typed.
- f. Application should be submit in English, Hindi or in Assamese.
